A confirmation with specific event instructions will be mailed to you with your reservation. Participants are entirely responsible for their own displays, booth set-up and removal. Food vendors must follow health regulations and laws. Due to the shortage of electrical connections on site, plan on providing your own generator. **There will be no refunds for cancellations made within 7 days of event.** All vendors are responsible for clean-up of rented spaces following the event.
